What's the fine print for the Better Real Estate discount?

- 1 Better Mortgage is offering lender credits to purchase borrowers matched with a real estate agent by Better Real Estate, LLC dba BRE, Better Home Services, BRE Services, LLC and Better Real Estate (“Better Real Estate”).
- 2 Purchase borrowers matched with a Better Real Estate Agent may receive \$2,000 in lender credits and purchase borrowers matched with a Better Real Estate Partner Agent † may receive up to 1% of the home sales price in lender credits.
- 3 This offer is available to purchase borrowers who have been notified that Better Real Estate has matched them with a real estate agent on or after July 9, 2021.
- 4 This offer is open to conforming loan product customers who have (a) entered a purchase contract on a home using the Better Real Estate Agent or Better Real estate Partner Agent; and (b) closed a mortgage loan on said home with Better Mortgage Corporation.
