- 1 Offer is open to real estate agent referral customers who have (a) entered a purchase contract on a home using a real estate agent referred by Finche, LLC, dba BRE, Better Home Services and Better Real Estate (“Better Real Estate”); and (b) closed a mortgage loan on said home with Better Real Estate’s affiliated mortgage lender, Better Mortgage Corporation.
- 2 If you use a real estate agent referred to you by Better Real Estate and choose to use Better Mortgage Corporation as your lender, you may be eligible for a discount of 1/8th of your interest rate on your purchase transaction.
